1. Construction Update and Discussion

The bid notice for Phase 3 was put in the Mountain Home Newspaper and the online public works site. Bids will be publicly open at the WECRD office on June 7th at 1pm.(*Edit: Date changed to June 14, 2021).

V. GENERAL DISCUSSION / PUBLIC COMMENT

Dan asked where we are at with the creekbed update. Lee said they have surveyed it but fell into a staffing issue so it has been delayed.

Michelle let the Board know the website has been migrated to the new platform. There are kinks that need to be worked out still and some pages updated.

The building permit application was submitted to the City of Mountain Home building department and since they outsource the plan review it will take time. We have not heard back from the City yet.

The audience asked for an explanation of the bid opening timeline. The bids will be opened on June 7th (changed to the 14th), then our construction manager will vet them and make sure all components of the scope of work are covered and then the Board will meet to award the bids.

Lee Pierce excused himself at 6:29pm for a fire call.

Betty informed the Board that the Foundation held a meeting on May 25th. They discussed ideas for the swim team to get involved with fundraising for various extras; score board, starting blocks, etc. Betty has letters of support for the aquatic center and will get Michelle copies so we can either use them or reach out to those people and get an updated letter of support. Betty said they discussed ideas for a groundbreaking ceremony to get the community excited. She is also working on the Idaho Women's Charitable Foundation grant and Steele Reese Foundation grant.
